ORDINANCE NO. 95 -34

AN ORDINANCE ESTABLISHING SPEED LIMITS
FOR MOTOR VEHICLES AND STOP INTERSECTIONS ON ROADWAYS
WITHIN MARION TOWNSHIP, CENTRE COUNTY, PA

I. **SPEED LIMITS:**

WHEREAS, there are certain streets and roads within Marion Township upon which no speed limits have been established; and

WHEREAS, the Marion Township Board of Supervisors, in order to advance the welfare and safety of the residents of the Township and such other persons who use said streets and roads, deems it necessary to enact speed limitations on certain streets and roads in Marion Township; and

WHEREAS, the Vehicle Code of Pennsylvania provides for the establishing of speed limits on streets and roads; and

WHEREAS, the Board of Supervisors, after completing engineering and traffic studies of the following streets and roads, find the following speed limits to be warranted in accordance with the Vehicle Code of Pennsylvania.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, and it is enacted and ordained, by the Board of Supervisors of Marion Township, as follows:

Section A: The maximum speed limit for the following streets and roads is hereby established as follows:

<u>STREET OR ROAD</u>	<u>BETWEEN</u>	<u>SPEED LIMIT (mph)</u>
Walnut Ridge Rd. T-485	End of pavement to S.R. 26	25
Rabbit Hill Rd. T-486	Between Walnut Ridge Rd. and end of pavement	25

II. **STOP INTERSECTIONS**

Section A: The following intersections are established as stop intersections and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second named Street (the intersecting or through Street) on the first named Street (the stop Street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first named or stopped Street in the direction

indicated in each case shall stop the vehicle as required by Section 3323(b) of the Vehicle Code, and shall not proceed into or across the second named or intersecting or through Street until he/she has followed all applicable requirements of that Section of the Law.

III. STOP INTERSECTIONS AND SPEED LIMITS

Section A. There shall be procured all official signs required under any of the sections of this Ordinance or any future amendment hereof or additions hereto; and which shall be erected, posted and maintained so as to properly give effect to the provisions of all of the sections of this Ordinance and properly to comply with law, including the requirements set forth in the rules and regulations of the Department of Transportation of the Commonwealth of Pennsylvania.

Section B. This Ordinance shall be enforced in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to enforcement, fines and other penalties.

Section C. Any provisions of any prior Ordinance which may be in conflict with this Ordinance is hereby repealed only insofar as a conflict may exist.

Section D. Should any provision of this Ordinance be found to be unconstitutional or otherwise illegal or in any manner unenforceable, the remaining sections of the Ordinance shall remain in full force and effect.

Section E. This Ordinance shall be enforced in accordance with the provisions of The Vehicle Code of Pennsylvania as it pertains to enforcement, fines and other penalties.

Section F. Should any provision of this Ordinance be found to be unconstitutional or otherwise illegal or in any manner unenforceable, be the Board of Supervisors of Marion Township, Centre County, the remaining sections of the Ordinance shall remain in full force and Pennsylvania, in lawful session duly assembled, effect.

Section G. This Ordinance shall take effect five (5) days after enactment thereof.

Duly enacted and ordained this 9th day of May, 1995, by the Board of Supervisors of Marion Township, Centre County, Pennsylvania, in lawful succession duly assembled.
